- (b) In the Pony Classes the name of the rider will be printed if included.
- (c) ENTRY FEES - Please consult Schedule. Cheques should be made payable to: Angus Agricultural Association.
- (d) Substitution of animals in place of these already entered but unable to be exhibited is not allowed except where BSJA rules allow.
