



## Angus Show Craft Marquee Saturday 6<sup>th</sup> June 2026

**Tickets & Car Passes:** Admission passes must be used to gain entry to the Showfield and will allow one person per pass to enter the Showfield.

**Pre-Paid Tickets:** Additional tickets are available for advanced purchase at a discounted price of £10 each per person for passes and £1.50 each for exhibitors' car park.

### General Rules

1. Your stand area in the marquee will be marked out by **2.00 p.m. on Friday 5<sup>th</sup> June** from which point, you will be given location details and access on arrival. Set up will be from 2.00 p.m. until 7.00 p.m. on Friday night or Saturday between 6.00 a.m. & 8.00 a.m. The Committee reserve the right to refuse entries from dealers in articles deemed not worthy of exhibition.
2. Application for space must be made on the printed form obtainable from the Secretary. All fittings will be erected by the exhibitor at his/her own expense.
3. Table must be set up and in position by no later than 8.00 a.m. on Saturday 6<sup>th</sup> June between the hours of 6.00 a.m. and 8.00 a.m.
4. No exhibitor will be permitted to sub-let the whole or part of the space allocated to him/her.
5. Stands must be arranged in such a manner so as not to inconvenience neighbouring exhibitors. Applications will be accepted on the strict understanding that space allocated is used for the display, promotion or sale of the items or services listed by the trader on their application. Traders and stand personnel must conduct their business only within the space allocated to them. All stall holders have a 6ft space included in the price for the event. You can use the space on your table, behind your table and in front of your table. If you require more space it would be advisable to take 2 tables at the cost of £30.00 per table.
6. **All vehicles must remain out of the showfield on Saturday from 8.00a.m. to 6.00p.m.**  
**No movement of vehicles is allowed during this time. (You will be given a Car Park Pass to display on your vehicle) PLEASE ENSURE it is DISPLAYED CLEARLY. Anybody who does not comply will risk having their vehicle removed.**
7. Delivery of refreshments can be made only before 8.00 a.m as no service vehicles are allowed on the ground after that time. In order to reduce the number of contractors and vehicles using the show ground, stand holders are encouraged to buy such light refreshments from the official catering contractors, details of which can be obtained from the Secretary.
8. Electricity can be supplied by the association at £5 for a point. Please bring own extension.
9. All participants are expected to comply with the above regulations, the main purpose of which is to avoid damage to the show field, inconvenience to the owner and to give visitors an enjoyable day.
10. No vehicles will be allowed into the showground after 8.00 a.m. but will have the use of the car park adjacent. No exceptions will be made.
11. All exhibitors and traders must have adequate insurance cover in place for all their property on the showfield. The AAA will not be liable for damage to property on tradestands or other property on the showfield connected with a tradestand if the damage is deemed beyond the control of the AAA. You will appreciate that these are Health & Safety Regulations.
